MEMBERSHIP CATEGORIES

ACTIVE (FULL) BREEDING MEMBER

An Active Member is an individual or body corporate with an interest in Hereford cattle admitted to membership under Rule 2.3 and who or which has not ceased to be a Member under any other Rule, but does not include an Associate, Life or Honorary Member.

YOUTH MEMBER

A Youth Member is an individual of or under the age of 30 with an interest in Hereford cattle admitted to membership under Rule 2.3 and who or which has not ceased to be a Member under any other Rule.

ASSOCIATE MEMBER

An Associate Member is an individual or organisation (incorporated or unincorporated) admitted to membership under Rule 2.3 and who or which has not ceased to be a Member under any other Rule. An Associate Member shall be entitled to a copy of or access to the Database on payment of such charge as may be set by the Council, but otherwise has no membership rights, privileges or duties.

OVERSEAS MEMBER

An Overseas Member is an individual or organisation (incorporated or unincorporated) with an interest in Hereford cattle admitted to membership under Rule 2.3 and who or which has not ceased to be a Member under any other Rule. An Overseas Member shall pay such application fee and annual subscription as shall be set by the Council, but otherwise has no membership rights, privileges or duties.

LIFE MEMBER

A Life Member is a person honoured for highly valued services to the Association elected as a Life Member by resolution of the Council. A Life Member shall have all the rights and privileges of a financial Active Member and shall be subject to all the duties of an Active Member except those of paying subscriptions and levies.

HONORARY MEMBER

An Honorary Member is a person honoured for services to the association or in an associated field elected as an Honorary Member by resolution of the Council. An Honorary Member has no membership rights, privileges or duties.
